RE: VOLUNTEER DRIVERS

Dear Parent/Guardian:

The Lighthouse Church of God relies many times on volunteer drivers to transport our youth to events around the area. The Lighthouse policy stipulates that volunteers show proof of car insurance, proof of ownership, and a valid driver's licence before driving to a church sponsored event. We also require that our drivers have their licence and a safe-driving record for at least 5 years, and that the vehicle being used is mechanically fit. These drivers must sign a contract with the church stating the above and agreeing to be a safe, responsible driver. Please be assured that your child's safety is our priority.
